WHAT IS GOVERNMENT SUBSIDIZED HOUSING?

Subsidized housing allows the tenant to pay rent that is less than market rate – often based on a percentage of the tenant’s income, generally 30 % of their income. (Housing that is paid for in part by the local, state or federal government.)

Subsidized Apartments

HUD helps apartment owners offer reduced rents to low-income tenants. To apply, contact or visit the management office of each apartment building that interests you. U.S Department of Housing and Urban Development: 1-800-955-2232/402-492-3101(Omaha Field Office)

WHAT IS AFFORDABLE HOUSING? Affordable housing has income maximums tenants can earn. Rent is market rate. (The government gives funds directly to apartment owners, who lower the rents they charge low-income tenants.)

WHAT IS LOWER RENT HOUSING OPTIONS?

Lower rent housing offers lower rent or accepts S8 (Section 8) or GA (General Assistance). It is not considered subsidized or affordable. There may be waiting lists for these rentals and at times may be closed to new applicants.

WHAT IS SECTION 8?

The Section 8 Housing Choice Voucher program enables low-income persons/families to rent from a private landlord with rental assistance administered by local Housing Authorities. Clients must find their own housing within the local Housing Authority jurisdiction.

To be eligible for Section 8, clients must be a U.S. citizen or non-citizen with eligible status, meet income guidelines established by HUD, and pass a criminal background check.

WHAT IS PUBLIC HOUSING?

Public housing was established to provide decent and safe rental housing for eligible low-income families, the elderly, and persons with disabilities. The U.S. Department of Housing and Urban Development (HUD) administers Federal aid to local housing agencies (HAs) that manage the housing for low-income residents at rents they can afford.
