## **Program Changes**

In January, a letter went out to our passengers who are considered to be "urban", announcing the discontinuation of the urban trips portion of our transportation services, **effective July 1st 2021**.

The trips that will be discontinued are those in which both the origin and the destination of the trip itself are within the boundary set by the U.S. Census Bureau, called "**Urbanized Omaha**". This boundary includes Bennington, Waterloo, Gretna, Papillion, Ralston, LaVista, and Bellevue.


