The Eastern Nebraska Office on Aging Rural Transportation Program operates in Cass, Dodge, Washington, and Sarpy counties, and the outskirts of Douglas county.

This program may be utilized by the general public and individuals with disabilities for any transportation needs; medical; business; shopping; airport, etc. Both handicapped & non-handicapped vehicles are available.

The Rural Transportation Program is funded through a grant from the Federal Transit Administration and the Nebraska Department of Roads. ENOA matches these grants with funds received from passenger fares and county revenue.

Individuals wishing to use the Rural Transportation Program may contact the ENOA office in their area. If this is a long distance call from your area, you may call collect. A minimum of 48 hours advance notice is required, but does not guarantee a ride; you can book a ride as much as 2 months in advance

- All rides are booked on a first come first serve basis. Our schedules change daily.
- An appeals/grievance policy is available if you feel you have been unfairly denied access to this program.
- The Americans with Disabilities Act (ADA) prohibits discrimination on the basis of disability in the provision of transportation services.
